Its mission is to provide decent, safe, and sanitary housing opportunities, improving the quality of life for low-income families, elders, and those persons with disabilities. This primary mission requires the coordinated efforts of LHA staff under the direction of the Executive Director using the Authority's resources in a manner that promotes economy of operation and efficiency. In support of its mission, stable and consistent job performance in all job duties is expected for the benefit of Authority's applicants, tenants, employees and vendors.

Through process of the SW/WL applicants apply regionally by applying through only one PHA and the application will be considered by all participating PHA's rather than to one PHA when many local PHA's have closed WL, allowing for an improved ability and opportunity for affordable housing. The SW/WL enhanced customer service with self-serve computerized application process, managing the WL procedures, preferences and improving SEMAP scores, while systematically, updating the WL.</p> <p><u>Current Goals:</u> Expand the HCV program with additional vouchers as provided by HUD. To promote community wellbeing through better provision of housing to meet diverse community needs. To provide housing choice by encouraging landlords to provide housing of different types, size in suitable locations, at a range of prices within the reach of households of varying financial capacity including an adequate supply of housing that is affordable for extremely low, very low, low and moderate-income households. To provide housing with programs like the Family Self-Sufficiency and the Homeownership Program in a way that contributes to the sustainability of communities that allows people the opportunity to pursue goals related to family, work, education, creativity, recreation or other pursuits. To encourage adaptable and accessible housing that can respond to the changing needs of residents. Continuing a 100% utilization without additional reserve revenue.</p>
