Dear Bidders,

We received a number of questions for the Trash Hauling bid. In addition, we would like to add alternates for bidding for 2 locations. Please see below for more information:

#### Questions:

1. Would you confirm the current provider? Would you confirm the current rate(s)?

Our current provider is EL Harvey. Attached is their bid form. Note that some of these services have changed since.

2. Is the Sterling location the correct address?

There is an error on page 14 under the scope of work for the Sterling Housing Authority. The service address for the Sterling location is 41 Sholan Terrace, Sterling, MA.

3. You have requests for totes in Leominster and Lunenburg. We do not provide tote service in those towns. Would a 2 yard dumpster on wheels work (a 2 yard dumpster is equal to 4 to 6 totes)?

We cannot accept toters in Leominster, but we can consider dumpster pick-up for the toters in Lunenburg. Attached is a new bid form to use with your bid submission that includes the addition of an alternate for dumpster pick-up in Lunenburg.

4. Also is the bid an all or nothing situation?

The bid originally stated that that the service provider is to provide a quote for all locations, however, we are going to waive this requirement. The bidder may bid on multiple locations. They are not required to submit a bid for all locations.



#### **Specification Changes:**

- 1. Page 7 Under Rule for Award:
  - a. Line 4: Revise to the awarded contactor may provide a bid for any location and is not required to submit bids for all locations.
  - b. Line 2. This procurement may result in multiple awards. We will award the contract to the lowest qualified bidder for each location.
- 2. Alternate 1 is issued for the toters in Lunenburg. We will accept an alternate quote for dumpster service vs. the proposed toter service.
- 3. Alternate 2 is issued for dumpster service in Holden. We will accept an alternate quote for dumpster service vs. the proposed toter service.
- 4. New Bid Form issued. The bid form attached must be used in place of the previous bid form. The amendments are related to the proposed alternatives above. For determining the bid deposit amount for each housing authority, please use the service that you are proposing to determine what the total contract price will be.
